 - Sue Starkey of NDDH: notify attendees about budget at the state level. The state funds health districts per capita and funds have been decreased by the government. This year the Appropriations Committee has proposed a budget that increases local health per capita at the district level by 75 cents. Sue will be writing a letter to the governor asking for support of this change and asks the board members of NECCOG for additional support.

- a. Transit Activities

• Although still below 'normal', transit ridership statistics for all services remain steady with a slight upward trend.

• ConnDot requested transit districts to provide list of enhancements/improvements related to our building and services. Some items included are a new roof, proposal of a route midday to and from Willimantic to link with Windham Region Transit District, also proposed a possible link to Webster and Southbridge, MA.

b. Animal Services Program

• Activities such as adoptions, redemptions, investigations, and impounded animals have not been affected by the COVID-19 pandemic.

• NECCOG Animal Services recently seized over 30 cats from 2 different homes and have begun the process of adopting them out. A horse was also adopted out.

c. Paramedic Intercept Program

• Paramedic services have remained steady.

j. Potential Change to "Urban" Definition

• Change may effect Worcester Urbanized Area - funds us \$538,000/annually for road projects, with several projects currently pending.

k. Crumbling Foundations

- HB 6646, File 550 An act concerning crumbling concrete foundation
 - This ill makes the Connecticut Foundation Solutions Indemnity Company (CFSIC) permanent by elimination the current June 30, 2022 termination date.
 - Allow the CT Housing Finance Authority (CHFA) to make loads to CFSIC so that it may pay claims.

• Extends the Health Homes insurance surcharge sunset date by 12 years, until December 31, 2041. Under current law, the surcharge sunsets on December 31, 2029.

• Requires the Department of Consumer Protection (DCP) commissioner to adopt regulations establishing standards for aggregate testing.

• Eliminates five-year cap on reduced assessments for properties made with defective concrete - allowing property owners to benefit from a reduced assessment until their foundation is repaired or replaced.

• Requires CFSIC to study the extent of the pyrrhotite-related foundation damage in nonresidential buildings and appropriates \$175,000 from the Healthy Homes fund for it to do so.

- CFSIC has 33 registered claimants in 27 month 7 are pending
- CFSIC has paid \$1,486,715 in foundation remediation and reimbursements claims
- CFSIC has completed 10 foundations in Ashford for a total call of \$1,469,215.
- 47 affected communities 1,729 applications
- If sunset date is not moved to minimum of 2030, at least 80% of our known 7 pending claimants will be left behind.
