a. Transit Activities

• Ridership activity is still below the pre-pandemic averages. NECTD still operational under COVID-19 protocols (masked drivers/riders, social distancing, limited capacity, etcetera).

• Elderly and Disabled ridership below average as well. Due to difficulties in finding/hiring new drivers in conjunction to recent retirements of our most current staff members - the Elderly and Disabled service will be operating on limited weekdays.

• Today, September 24, NECTD is assisting with veteran transportation with the Veteran's Stand Down.

• Plainfield Bus Service has been successful despite COVID-19. July 2021 ridership reached 306 at an all time high since the pilot program began.

b. Animal Services Program

• Activities such as adoptions, redemptions, investigations, and impounded animals have not been affected by the COVID-19 pandemic.

• Norwich kennel is now open, and NECCOG is now serving 20 towns.

• Animal Services Officers will be at the Norwich facility daily to help close the gap in response time for the southern participating towns.

• NECCOG Animal Services is currently housing 14 birds, 18 dogs, 27 cats, and 2 rabbits due to the result of two search and seizures.

c. Crumbling Foundations

- CFSIC has put 367 families back in safe and secure homes.
- To date, CFSIC has 1,848 registered claimants within their systems.


