### 2. Director's Report - John Filchak, Executive Director

#### a. Transit Activities

- Due to driver shortages and COVID-19 impacts, NECTD runs have been modified to provide continue service.
- Buses are limited to 5 passengers at any one time.
- Plainfield pilot route has had no disruptions.

#### b. Animal Services Program

- Activities such as adoptions, redemptions, investigations, and impounded animals have not been affected by the COVID-19 pandemic.
- Since the opening of NECCOG's Norwich location, there have been 56 investigations.
- The town of Andover has recently joined NECCOG's Animal Services Program.

#### c. Paramedic Intercept Program

- September Statistics : 317 calls for service, 222 ALS transports, and 1 cardiac arrest with resuscitation attempt
- 2021 Statistics through October: 1,832 Total ALS transports

#### d. Crumbling Foundations

- CFSIC has put 400 families back in safe and secure homes since the program began on May 15, 2019.
- Funding:

## e. Regional REVAL Program

- The contract meets the inspection requirements of 12-62.
- Subsection 3 of 12-62 requires all properties to be inspected over a 10 year period. With this project being the start of a new 1- year cycle, Vision will be inspection 50% of the properties, and the next project will cover the 2nd 50% of the properties.
- The service being provided also includes Data Mailer being sent to homeowners.
  - The sending and receiving of Data Mailers would eliminate the need for the property to be inspected.
- Vision is conducting on-site inspections for 50% of the improved properties in each community. This includes inspections for major Data Mailer discrepancies, sold properties that will be utilized in the sales analysis and properties with outstanding building permits in each community.
- Mid-November meeting with assessors from the participating towns will be scheduled to address any questions.
