"The Regional Performance Incentive Program was established in 2007 to encourage municipalities to participate in voluntary inter-municipal or regional shared services projects that have the potential to produce measurable "economies of scale", provide desired or required public services, and lower the costs and tax burdens associated with the provision of such services." - OPM

Criteria (as put forth in Public Act 21-2, Section 177) for RPIP Proposals::

- ٠ council of governments or regional educational service center regardless of such members' participation in the grant application process;
- ٠ proposal demonstrates (i) a positive cost benefit to such members, (ii) increased efficiency and capacity in the delivery of services, (iii) a diminished need for state funding, and (iv) increased cost savings;
- ٠ a reduction in economic or social inequality;
- statement that not less than twenty-five per cent of the cost of such proposal shall be funded by the council or center in the first year of operation, and that by the fourth year of operation the council or center shall fund one hundred per cent of such cost; and
- Any employee organizations that may be impacted by such proposal have been informed of and consulted about such proposal, pursuant to subsection (c) of this section.
