# What is a CEDS?

- CEDS is short for "Comprehensive Economic Development Strategy" - an extensive process managed by the U.S. Economic Development Administration (EDA)
- Planning document required by EDA to be eligible for federal funding through their grant programs
- A CEDS is designed to bring together the public and private sectors in the creation of an economic roadmap to diversify and strengthen regional economies

#### Purpose:

- Analyzes regional conditions
- Identifies strengths, weaknesses, opportunities and threats (SWOT)
- Defines the vision, goals and objectives of the region
- Designs strategies to accomplish goals and identifies needed projects
- Provides a process for regional dialogue and CEDS evolution








# Median Age in the Region (2000)

# Median Age in the Region (2020)


93.8% of NECCOG towns had a median age over 40 in 2020 (this is up from 12.5% in 2000).

Half of the population in 15 towns was over 40 in 2020.


Ashford = Lowest+ Union = Highest


#### Occupations of Residents in Region (2020)


