- 3. Director's Report John Filchak, Executive Director
 - a. Regional Transit Services Program
 - Decline in ridership and lack of drivers is an on going issue.
 - b. Regional Animal Services program
 - Two new legislative documents were present by the Director: Public Act No. 23-17, Public Act No. 23-138 (See slides for more information).
 - c. Paramedic Intercept Program
 - The Director showed most recent numbers reflecting January July 2023.
 - d. Crumbling Foundations
 - 800 families foundations repaired and rising.
 - e. Environmental Depot
 - DEEP asked the Director for more information regarding application, waiting for response for future plans.
 - f. Regional Revaluation Program
 - Section 7 of Public Act 22-74 sets up new revaluation zones based on the council of governments as well as new revaluation dates. Brooklyn, Canterbury and Pomfret are being moved to 2024 from 2025 to accommodate the new law.
