- a. Regional Planning & NECTD Services
 - Decrease in S&D ridership.
 - New Transit website to be launched soon.
- b. Safe Street 4 All Grant
 - For interested municipalities to contact Jim Larkin jim.larkin@neccog.org
- c. Long Range Transportation Plan
 - Currently conducting public outreach and final adoption including regional and individual projects.
- d. Transportation Rural Improvement Program
 - Possible Fall 2024 Solicitations to be announced with a 20% match. For towns to continue with applications to contact Jim Larkin.
 - The Draft 2025 STIP was presented to public fulfillment.
- e. Transportation Alternative Program (TAP)
 - Applications received from Plainfield and Putnam.
- f. Active Transportation Micro Grant Program
 - Eligible municipalities and 501(c)(3) non profits will be provided with up to \$5,000 in funding for
 resources including bike helmets, fleets, safety vests and more. Bike racks are <u>not</u> eligible at this
 time
 - Program works in connection with CTDOT's Safe Routes to School Program and to be administered by the regional COGs.
- g. PROTECT (Promoting Resilient Operations for Transformative Efferent and Cost Savings Transportation.)
 - Program will be used to assist 94 municipalities represented by COGs.
 - Scope of work is currently in development. The plan will evaluate the risk and impacts of extreme weather events and natural hazards.
